VENDOR RULES & REQUIREMENTS

Arts & Crafts:	Original handmade arts and crafts only. No commercial or manufactured resale items. Sponsor reserves the right to prohibit any items considered in bad taste and to prohibit and/or remove vendors who sell commercial and manufactured items from the festival.
Exhibit Hours:	Saturday and Sunday from 9 am – 6 pm.
Exhibit Space:	Location is along SW and NW Main St in Pierce Park on either grass, concrete or asphalt. Each space is approximately 10' X 10'. Exhibitors will be responsible for all booth structures, set-up and furnishings (e.g. tents, coverings, extensions cords*, signage, etc.).
Set up:	Set up may begin at 5:00 pm on Fri. 4/16/10 . Booths must be completely assembled and open at 9:00 am on Saturday. No booths will be allowed to set up or close early without prior permission from the Festival Committee. All Exhibit participants are responsible for dismantling and cleaning space before leaving. No participant will be allowed to set up without a signed, dated & approved application.
Security:	Participants are responsible for the security of their goods & property. The Festival Committee nor Festival Sponsor will be responsible for stolen, lost or damaged property, accidents or injury.
Fees & Registration:	Each 10' X 10' exhibit space is \$80. Food booths are \$100. \$25 for electricity. To reserve your space, please complete the form below. Please make your check payable to Ennis Garden Club. Mail your application and check to Ennis CVB /P.O. Box 1237/Ennis, TX 75120. ALL FEES ARE NON-REFUNDABLE – EVEN DUE TO INCLEMENT WEATHER. Deadline: Applications must be received by March 15, 2010. If space is filled or if you have not been accepted into this event, you will be notified by March 22 and your fee will be returned. Questions? Call 972-878-4748. Special Note to Food Vendors: Individual city food permits are required for any type of food for consumption. Cost of permit is \$25; submit with the separate attached application. Therefore, total exhibitor cost is \$125 for food vendors. An additional \$25 if electricity is needed. Vendor and permit application must be completed and approved by Committee and health inspector.
